WAIVER AND RELEASE

I, the undersigned participant or parent/legal guardian of minor participant, on behalf of myself, my minor children, heirs, executors, personal representatives and successors in interest hereby EXPRESSLY, KNOWINGLY, VOLUNTARILY, AND IRREVOCABLY RELEASE, WAIVE, FOREVER DISCHARGE, AND AGREE TO INDEMNIFY AND HOLD HARMLESS SIDELINE SPORTS, LLC AND EACH OF ITS RESPECTIVE EMPLOYEES, AGENTS, OWNERS, MANAGERS, AND AFFILIATES, FROM ANY AND ALL LIABILITY FOR ANY AND ALL CLAIMS, DEMANDS, OR CAUSES OF ACTION WHICH ARE IN ANY WAY CONNECTED WITH MY OR MY MINOR CHILD'S PARTICIPATION IN THIS ACTIVITY OR MY OR MY MINOR CHILD'S USE OF THE SIDELINE SPORTS, LLC FACILITIES, EQUIPMENT OR SERVICES.
